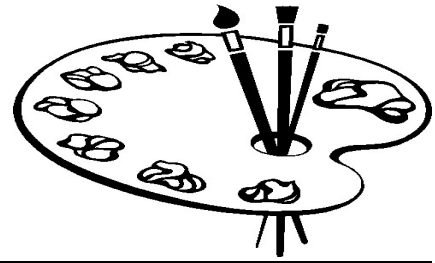
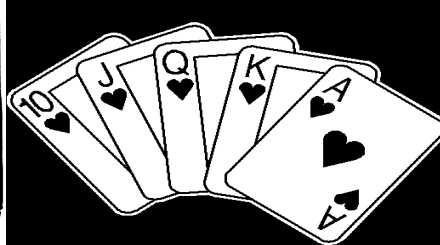
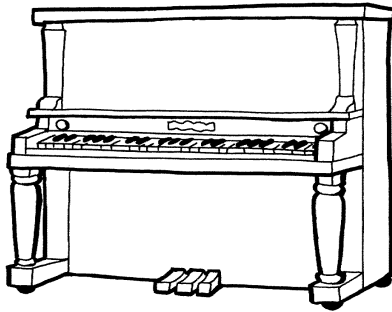


# ***NC ASSISTED LIVING ACTIVITY PROFESSIONAL TRAINING CLASS***

Sponsored by The Coalition of Resident Councils (The CORC) and is approved by the Division of Health Services Regulation (DHSR), Adult Care Licensure Section.

This course meets the administrative code 10A NCAC 13F .0404 (2) "Qualifications of Activity Director" for Adult Care Homes in NC.



The course will meet on Tuesday nights over the course of 9 months from 6:30 pm to 9:30 pm via the internet. Week #1, the class will meet for one (1) hour only from 6:30 pm to 7:30 pm for class orientation. A Zoom meeting format will be utilized. You need to have a camera and microphone on your computer in order to participate in this virtual classroom.
